Course Description

Study of the historical backgrounds, governing principles, and institutions of the national government of the United States.

Prerequisites and/or Corequisites

Course Competencies

1. Discuss the causes of the American Revolution and why the American Revolution is consistent with British values.
2. Explain how the Constitution remedies the main defects of the Articles of Confederation.
3. Explain how Federalism, Separation of Powers, and Checks and Balances address concerns about concentrated political power.
4. Explain the mechanism for amending the U.S. Constitution.
5. Identify the major civil liberties and civil rights issues in the U.S.
6. Describe the party leadership structure in both the U.S. House of Representatives and the U.S. Senate and how this leadership structure impacts the policymaking process.
7. Identify the steps involved in the lawmaking process in the U.S. Congress.

8. Identify the constitutional powers of the U.S. President as well as the constraints on the exercise of those powers.
9. Outline the organization and role of the federal bureaucracy in carrying out executive branch functions.
10. Describe the structure of the federal courts as well as the process for appointing federal judges.
11. Trace the development of political parties and interest groups and differentiate between the functions each performs.
12. Examine the process of political socialization in the U.S.
13. Examine the roles that the media and public opinion play in the U.S. political system.
14. Explain the role that elections play in U.S. politics and the major criticisms of the electoral process.
