10. Describe the historical impact of Christianity in the western world.

Rather they are designed for students to process information, share their perspectives, question each other and ultimately clarify their own views.
4. Discussion posts are expected to primarily reflect engagement with the materials that students read and watch in the audio/visual portion of the website. Students are to be specific in their responses and precise in quoting or describing elements from the readings or visuals to which they are responding.
5. Submitted work must be unique to each student.

1. Participation on the discussion board and assignment completion is absolutely required and essential to achieve course objectives and are the basis for attendance.
2. All assignments are to be completed no later than 11:59pm on the day they are due or they will be considered late.
3. Postings and quizzes will have 5 pts deducted each day they are late. Points will be deducted until the assignment has reached zero points. For example, an assignment due by 11:59 pm on May 6 that was actually posted on May 8 would be considered 2 days late and would have 10 points automatically deducted from it.

Response Time
